1.0 Introduction

This document is the FAA Approved Model List for STC No. SR00359BO for installation of the Parmetheus Plus LED Landing and Taxi Light Assemblies on Part 27 Normal Category Rotorcraft. Revisions to this AML must be coordinated between the STC holder and the responsible ACO. Revision requires an FAA approval.

2.0 Certification Basis

The certification basis and amendment level for each model qualified for this modification is as defined in the approved model list, Table 1.
